Marine Emergency Response Exercise



On **Tuesday 8 April, between 8:30am - 12:00pm**, Ampol will be participating in a marine emergency response exercise, in collaboration with Port Authority NSW.

As part of the exercise, the terminal siren will be sounded with 2 x 10-second blasts between 8:30am - 9:00am and a 1 x 10-second blast between 9:30am - 10:00am.

The siren is used to notify on-site personnel of the need to proceed to the nearest muster location. Normal daily testing of the alarm will still occur at 12:00pm (1 x 10-second blast).

We will also use this opportunity to test our community notification platform. In the unlikely event of a major incident at the terminal, Ampol will use this platform to send initial alerts and information to registered participants.

On Tuesday 8 April, the following messages will be sent by either SMS, voice message or email:

"Dear Ampol neighbour, this is a test of the Ampol community notification platform. This is a test only. No action is required. Thank you".

"Dear Ampol neighbour, the all clear has been sounded at the Ampol Terminal. Thank you".

Testing of our systems are essential to ensure our emergency response procedures remain current and effective. We appreciate the community's understanding and cooperation as we conduct this important safety drill.

Ampol Kurnell Energy and Industry Hub

Per prior updates, the modification application to the State Approval at the Site (SSD 5544 for the Refinery Conversion) (referred to as MOD-7) has now been prepared for the Department of Planning, Housing and Infrastructure's (DPHI) review.

MOD-7 will support the safe ongoing operations at the Terminal and improve the refinery's redundant land by relocating and/or removing infrastructure and undertaking further land remediation. The MOD-7 Report will be on exhibition for the community to provide feedback.

Further to previous communication on the Kurnell Battery Energy Storage System's (BESS) State Significant Development (SSD) application and Scoping Report initially lodged in November 2023, a revised Scoping Report has been finalised to now include subdivision land works and will be sent to DPHI shortly to request the Secretary's Environmental Assessment Requirements (SEARs).

On the 7 May 2025 we will hold a community drop-in session to present details on both projects and more information on this session will be provided in the next Ampol Community Update.

Foam transition project - wharf

We would like to inform local residents of work scheduled to take place on the Ampol Wharf as part of our foam transition project.

This important project is focused on upgrading our foam firefighting systems to align with updated environmental standards, as required by the NSW Environment Protection Authority (EPA).

Work will coincide with ship free windows commencing in April and continuing over several months. You may notice increased activity on the wharf including the use of a crane, trucks, and other equipment.

We are keen to ensure the community are not unduly impacted and we will monitor mitigation measures throughout the project.

Our siren is tested everyday at 12noon with a 1 x 10 second blast, and 2 x 10 second blasts on Mondays.

The siren is for on-site personnel only and people in the community do not need to take action.

In the event of a major incident that has potential to impact the community, Ampol will provide initial alerts and information via its community notification platform. Residents are advised to always follow any direction from emergency services.
